GENERAL SUMMARY

This position is accountable for facility maintenance and machine repair, including cleaning and sanitizing as scheduled. Objective to provide GLE employees, customers, and visitors with a clean and orderly facility.

PRINCIPLE DUTIES AND RESPONSIBILITIES (ESSENTIAL FUNCTIONS)

1. Clean assigned rooms, areas, and hallways
2. Remove garbage and empty trash cans and dumpsters
3. Restock supplies in lunchrooms, janitorial closets, restrooms, wash areas, and other designated areas as needed.
4. Building repair (Including painting and repair)
5. Follow written and verbal instructions from Supervisor
6. Follow and continually monitor established safety procedures to assure a clean and safe work environment is promoted and maintained.
7. Machine cleaning and repair as directed by Supervisor.
8. Machining to include Grinding
9. Maintain a positive work atmosphere by behaving and communicating in a manner that interfaces well with customers, clients, co-workers, and management members.
10. Perform other ad hoc duties and projects as assigned

JOB SPECIFICATIONS

1. Minimum of a High School Degree or equivalent
2. Previous maintenance experience preferred.
3. Previous custodial experience preferred
4. Knowledge of safe use of cleaning chemicals preferred, including but not limited to glass cleaners, disinfectants, toilet bowl cleaners, floor soaps, floor finishes, strippers, degreasers, waxes, de-limers, extraction rinses, and cream cleansers.
5. Knowledge of and previous use of Power tools
6. Ability to understand and follow written and spoken English
7. Ability to safely use and tolerate required cleaning chemicals
8. Ability to use safety equipment, such as gloves, safety glasses, etc.
9. Ability to use cleaning equipment, including but not limited to hand brooms, push brooms, dust mops, wet mops, mop bucket and wringers, vacuums, carpet extractors, automatic scrubbers, burnishers, automatic sweepers, side to side scrubbers, buffers, all surface cleaners, and recycling bins.
